### **Submissions**

If accepted for publication there is no page or publication fee.

All submissions are acknowledged and subject to a double, blind review process.

### **Subscriptions**

### **Format**

The journal is very flexible in what would be acceptable formatting. Generally we prefer a 12 point font, double spaced. For ease in review, the title, author(s) and affiliations should be on the cover page, followed by the title and abstract starting the body of the manuscript. The author is free to choose the font, as well the heading style and layout.
